# CERTIFICATION OF TAXABLE VALUE INSTRUCTIONS

“Principal Authority” is a county, municipality, or independent special district (including water management districts).

“Taxing Authority” is the entity levying the millage. This includes the principal authority, any special district dependent to the principal authority, any county municipal service taxing unit (MSTU), and water management district basins.

Each taxing authority must submit to their property appraiser a DR-420 and the following forms, as applicable:

- DR-420TIF, *Tax Increment Adjustment Worksheet*
- DR-420DEBT, *Certification of Voted Debt Millage*
- DR-420MM-P, *Maximum Millage Levy Calculation - Preliminary Disclosure*

## Section I: Property Appraiser

Use this DR-420 form for all taxing authorities except school districts. Complete Section I, Lines 1 through 9, for each county, municipality, independent special district, dependent special district, MSTU, and multicounty taxing authority. Enter only taxable values that apply to the taxing authority indicated. Use a separate form for the principal authority and each dependent district, MSTU and water management district basin.

### Line 8

Complete a DR-420TIF for each taxing authority making payments to a redevelopment trust fund under Section 163.387(2)(a), Florida Statutes or by an ordinance, resolution or agreement to fund a project or to finance essential infrastructure.

Check "Yes" if the taxing authority makes payments to a redevelopment trust fund. Enter the number of DR-420TIF forms attached for the taxing authority on Line 8. Enter 0 if none.

### Line 9

Complete a DR-420DEBT for each taxing authority levying either a voted debt service millage (s.12, Article VII, State Constitution) or a levy voted for two years or less (s. 9(b), Article VII, State Constitution).

Check "Yes" if the taxing authority levies either a voted debt service millage or a levy voted for 2 years or less (s. 9(b), Article VII, State Constitution). These levies do not include levies approved by a voter referendum not required by the State Constitution. Complete and attach DR-420DEBT. Do not complete a separate DR-420 for these levies.

Send a copy to each taxing authority and keep a copy. When the taxing authority returns the DR-420 and the accompanying forms, immediately send the original to:

## Section II: Taxing Authority

Complete Section II. Keep one copy, return the original and one copy to your property appraiser with the applicable DR-420TIF, DR-420DEBT, and DR-420MM-P within 35 days of certification. Send one copy to the tax collector. “Dependent special district” (ss. 200.001(8)(d) and 189.403(2), F.S.) means a special district that meets at least one of the following criteria:

- The membership of its governing body is identical to that of the governing body of a single county or a single municipality.
- All members of its governing body are appointed by the governing body of a single county or a single municipality.
- During their unexpired terms, members of the special district’s governing body are subject to removal at will by the governing body of a single county or a single municipality.
- The district has a budget that requires approval through an affirmative vote or can be vetoed by the governing body of a single county or a single municipality.

“Independent special district” (ss. 200.001(8)(e) and 189.403(3), F.S.) means a special district that is not a dependent special district as defined above. A district that includes more than one county is an independent special district unless the district lies wholly within the boundaries of a single municipality.

“Nonvoted millage” is any millage not defined as a “voted millage” in s. 200.001(8)(f), F.S.

### Lines 12 and 14

Adjust the calculation of the rolled-back rate for tax increment values and payment amounts. See the instructions for DR-420TIF. On Lines 12 and 14, carry forward values from the DR-420TIF forms.

### Line 24

Thank you for participating in the Department of Revenue's eTRIM system for completing and certifying your 2010 DR-420 TRIM forms. This email is to advise you of a modification to the system that will allow the entry of multi-county rolled-back rates on the DR-420 and DR-420MMP forms and to let you know of an issue which will require that district-wide summary forms be completed off the eTRIM system.

First, the issue of entering a district-wide rolled-back rate. As you know, the rolled-back rate entered on individual county forms for multi-county districts is the rate calculated for the entire district, not the rate that would be calculated only for the individual county. Because all counties are not participating in the eTRIM system, the district-wide rolled-back rate cannot be calculated within the system. A grid has been added to the first screen that appears after logging-in that allows multi-county districts to enter the correct district-wide rolled-back rate for each of their levies. These rates must be calculated off-line. When entered in the grid, they will automatically be entered into the individual county DR-420 and DR-420MMP forms.

Secondly, on the eTRIM system the district-wide summary forms are automatically filled in based on the entries in the individual county forms. However, because not all counties are participating only partial data is currently being entered. This is to advise you that the Department will not be able to correct this problem this year. As a result, in addition to submitting the individual county forms on the eTRIM system, multi-county taxing authorities will have to also submit hard copies of their summary forms to each of the property appraisers using the eTRIM system. These should be the same forms prepared for and submitted to those counties not participating in the system.

Each property appraiser participating in the eTRIM system is also being copied with this email to make them aware of the issue with district-wide summary forms. Property appraisers are requested to forward these district-wide forms to the Department as they have done in past years with all forms submitted. We apologize for this inconvenience. It should be corrected for next year.




